

## Enhancements/Features

### Documents | Multi Document Upload - Defaulting Choices [00152712]

When users upload multiple file such as documents, photos, etc. they can set the document type and security and type a description to apply to all the uploads (instead of doing this one at time).

When users select two or more files to upload, the app opens a shared document detail section above the file list. This section shows three fields: Document type (required), Security (required), and Description (required when using the app with SedonaOffice).



The app applies any values that users select to all the files for upload. There are no default or pre-selected values for these fields.

Users can see the details for each file individually. The details default from the shared details they already selected. Users can change the individual file details, and any changes affect only that file.

## Application Corrections

### **SedonaOffice/Sedona-X Mobile**

#### **Documents | PDFs | Pdfs are coming out blurred on preview [00153148]**

Users were unable to read PDF file documents due to blurry images. This affected all technicians.


We fixed this issue so that PDF files are clear and readable.

### **Manageley/Sedona-X Mobile**

#### **Work Order | Parts | Editing Parts causes part kit to add to parts [00150143]**

When a technician edited any part on a work order that had a part kit, the part kit was added to the parts section as a part for same amount as the part kit.

We fixed this so that part kits are no longer added as a part with an amount. In addition, we added a label to part kits, so users can see them when looking at the parts list:



#### **Work Order | Not showing full description on active work orders [00152359]**

Users reported that the entire description was visible for completed work orders but only one line of the description was visible for active work orders.

We changed the description text field so that it expands to show all lines of the description.

## **Special Upgrade/Install Instructions**

**Operating System** — iOS devices and Android devices should be using the latest Android and iOS versions available for full compatibility, although earlier versions may be able to support the app.

**SedonaOffice** — SedonaOffice will need to meet the system minimums (below) to support the Sedona-X Mobile app.

**SedonaWeb/SedonaAPI 2.0** — IT will need to update your SedonaWeb/SedonaAPI 2.0 version to meet the system minimum (below) at the same time as your SedonaOffice version. This is to ensure compatibility with the Sedona-X Mobile app.

### **Minimum System Requirements**

- SedonaOffice version 6.2.0.21 Rev 3
- SedonaWeb/SedonaAPI 2.0 version 1.52.0
- Server (where SedonaWeb/SedonaAPI 2.0 is installed) has Microsoft .NET 4.8 installed
